Modus Operandi

Crime Code(s) ASSAULTS

Narrative

On 8-25-11 and at 2011 hours reporting officer was dispatched to the EPD station to receive information on a non-aggravated assault. Upon arrival I was contacted by the victim, who stated that she had been assaulted earlier this date by the listed suspect. According to the victim, she and a girlfriend, the listed witness, went to The Point nightclub on the evening of 8-24-11. At approx. 0140 hours on 8-25-11, the witness was dancing with the suspect inside The Point, when the Other confronted the witness on the dance floor. The witness and the Other began fighting and a large crowd assembled. The witness and the Other exited the building, but engaged in another confrontation on the sidewalk outside of The Point. At this time, the victim attempted to pull the witness away from the Other at the same time, the suspect ran up to the victim and stated, "I will [REDACTED] up a [REDACTED]". According to the victim, the suspect then grabbed the victim by the left upper arm, and struck the victim in the right eye with his hand or fist. The blow caused the victim to fall backward onto the ground. During the assault, KCPD arrived on the scene and disbursed the crowd. The victim further stated that she did not want to drive her vehicle home after the assault, and was offered a ride to the Plaza by a friend of the suspect, Other 2, that plays for the Kansas City Chiefs football club. The victim accepted the ride. The victim was picked up on the Plaza by friends and driven home. The victim did not seek medical attention.

My investigation revealed the victim to have a dark bruise approx. 4-5 inches long on the underside of her upper left arm. I also observed bruising under the victim's right eye. Photographs of these injuries were taken at the
